

(A) Consent to Digital Transactions. You confirm that you have consented to transacting electronically with Vacation From Cleaning and signed an electronically created Agreement using an Electronic Signature. By doing so, you also agree to the terms of the Agreement and that the Agreement may be Authenticated, Stored and Transmitted by Electronic Means (as defined below), and will be valid for all legal purposes, as set forth in the Uniform Electronic Transactions Act as enacted in the applicable state jurisdiction, or other applicable state law governing the electronic signatures and records ("UETA"), the Electronic Signatures in Global and National Commerce Act ("E-SIGN"), or Section 9-105 of the Uniform Commercial Code as enacted in the applicable state jurisdiction ("UCC 9-105") as applicable. This Agreement will be an effective, enforceable and valid Transferable Record or Authoritative Copy (as defined below) and may be created, authenticated, stored, transmitted and transferred in a manner consistent with and permitted by UETA, E-SIGN or UCC 9-105. Your consent covers all communications relating to the Vacation From Cleaning Platform or Marketplace. Your consent remains in effect until you give us notice that you are withdrawing it.

(B) Withdraw of Consent. You have the right to withdraw your consent at any time. Please be aware, however, that withdrawal of consent may result in the termination of access to the Vacation From Cleaning Marketplace. Your withdrawal of consent will become effective after we have had a reasonable opportunity to act upon it. To withdraw your consent, you must contact us at info@vacationfromcleaning.com.

(C) Paper Copies. If we provide Electronic Records to you, and you want a paper copy, you may contact us at info@vacationfromcleaning.com and request a paper version. You may have to pay a fee for the paper copy unless charging a fee is prohibited by applicable law.

(D) Current Email or Electronic Address. You must promptly notify us of any change in your email or other electronic address. To do so, you must contact us at info@vacationfromcleaning.com.

(E) Transfer, Third-Party Rights. You understand that Vacation From Cleaning may digitally transfer this Agreement in a manner consistent with and permitted by UETA, E-SIGN or UCC 9-105 as provided in Section (A) above. Vacation From Cleaning or anyone who takes this Agreement by transfer, and who is entitled to receive payments under this Agreement, is called "Vacation from Cleaning" with all rights provided under this Agreement.

(F) Terms. The following terms and phrases are defined: (i) "Authenticated, Stored and Transmitted by Electronic Means" means that this Agreement will be identified as the Agreement that you signed, saved, and sent using electrical, digital, wireless, or similar technology; (ii) "Electronic Record" means a record created, generated, sent, communicated, received, or stored by electronic means; (iii) "Electronic Signature" means an electronic symbol or process attached to or logically associated with a record and executed or adopted by a person with the intent to sign a record; (iv) "Record" means information that is inscribed on a tangible medium or that is stored in an electronic or other medium and is retrievable in perceivable form; (v) "Transferable Record" shall have the same meaning ascribed to it under the Transferable Records provisions of UETA or E-SIGN, as applicable; (vi) "Authoritative Copy" means, with respect to any electronic record, a copy of such record that is unique, identifiable and, except as otherwise provided in UCC 9-105 or the Transferable Records provisions of UETA or E-SIGN (as applicable), unalterable, and is marked "original" or has no watermark or other marking that would indicate that it is a "copy" or "duplicate" or not an original or not an "authoritative" copy.
